When a Coordinator reaches 3 months of consecutive on-time and complete reporting, 5 Prestige of their award will be converted to Regional Prestige. In other words, if your award would be 40 General Prestige, you will instead receive 35 General and 5 Regional Prestige. For each additional month that you are on-time and complete, you will also have 5 Prestige of your award converted. If you are late or incomplete on a report, your count will start over. In other words, if you are on-time and complete 2 months in a row, late on the third month and on-time and complete on the fourth month, you will be considered to be on time 1 month and need 2 more months of on-time complete reporting to receive the award. Under each Coordinator's name is a listing of the months, starting in July 2004. Underneath each month is a letter: N means No Report, I means Incomplete Report, L means Late Report, O means Late and Incomplete Report, R means On Time and Complete Report. This format may change, so check here for any clarifications.
