Under each Coordinator's name is a listing of the months, starting in month of taking office. Underneath each month is a letter: N means No Report, I means Incomplete Report, L means Late Report, A means Late and Incomplete Report, C means On Time and Complete Report. This format may change, so check here for any clarifications.
