When a Coordinator reaches 3 months of consecutive on-time and complete reporting, 5 Prestige of their award will be converted to Regional Prestige. Under each Coordinator's name is a listing of the months, starting in July 2004. Underneath each month is a letter: N means No Report, I means Incomplete Report, L means Late Report, O means Late and Incomplete Report, R means On Time and Complete Report. This format may change, so check here for any clarifications.
