QUESTIONS FOR NATIONAL:

QUESTIONS ANSWERED BY REGIONAL:

Q. What are things that we can do on a low income domain to work on raising money to help the domain and the community?

A. Site fee is one way to do this. Another is various fundraisers such as car washes, garage sales or bake sales. One thing that I have seen be successful in the past is a "pay to play" type game which is a non-chronicle game where you build your character based on what you pay. If you are interested in more details, contact me privately.

Q. If a domain votes on it can game sites be enforced, but if a member can not pay, are they still allowed to play has came up a couple times in the domain meeting last month?

A. I recommend having some way those who absolutely cannot pay can still play. One thing I have seen work is that they have to do some work (such as narrating, running the cash box, whatever is needed in the domain) without receiving prestige for it. Another is an IOU system whereby you can have 3 IOUs on file before you are asked not to play.

Q. One of my members renewed, and was issued a new membership number when he did so. I am including both his old number and his new number in this report. Due to the fact it was a computer glitch, I am not removing any of his MC benefits and am planning on using his new number in the future.

A. Contact Membership Services to see if they can reassign him the old number. This will make it much easier for future prestige reviews.

Q. I have two MC reviews to be done. One is for a MC 8 (pending 9) player and the other is my own review for MC 5. Once I have these logs in order, who do I need to send them to?

A. If the log is being reviewed for MC 9+ or has prestige from June 2001 or before, send it to me for review and/or a national lock in.

If the log is being reviewed for MC 6-8 and does not have prestige from June 2001 or before, it is completed once the DC has reviewed it. If the log is being reviewed for MC 6-8 and does not have prestige from June 2001 or before, it is completed once the CC (or DC if no CC) has reviewed it.

Q. I did a MC review for Cameron Clemmer, US2005116919, in the process of updating her Prestige logs. She has moved to MC 5 from MC 3 (due to poor record keeping on the part of herself and the former DC). She had moved and was unable to find her logs after her most recent move. However, part of her prestige is under the name she used to go by in the Camarilla, Cameron Girt. Is there any way of changing the records on the NC prestige database to indicate that her name is actually Cameron Clemmer and not Cameron Girt? Who would I need to talk to about this?

A. Just make a notation in the name portion of the log that she was formerly known as (fna) Cameron Girt. Also make sure to include her NPO membership number for further clarification. This should suffice as verification.
