QUESTIONS FOR NATIONAL:

QUESTIONS ANSWERED BY REGIONAL:

Q. We are still awaiting the Prestige awards for 1st Night 2005. They have, to my knowledge, not been posted anywhere as of yet.

A. Per discussions on the Coordinators list, these are currently pending the websites to come back online to be posted.

Q. Are you guys still planning on having a campout mini-regional type thing there in Wichita?

A. The campsite we were going to use fell through as they no longer allow gaming on site. We are trying to get a couple rooms as the university and hopefully will post something within the next week. Also, if anyone is interested in hosting another mini-regional (for whatever venue), please let me know.

Q. The DST spoke to me the other day about the fact that multiple members of the domain are actively complaining about games, basically saying "if person X is there then I don't want to be". The griping has gotten to the point where she is seriously considering stepping down as she is tired of trying to get people to play nice with each other. Suggestions on how to help resolve both her problems, and the underlying idea of "I don't like how X plays so I don't want to play at a game they are playing at"?

A. I recommend going through the Conflict Resolution process outlined in the Handbook, specifically the Open Discussion and Mediation phases, with the individuals involved and try to get to the bottom of why they don't want to play with each other. It is very possible that there is some perceived slight or underlying problem that needs to be addressed and that once addressed would allow everyone to play together.

Q. Who gives VST prestige? Is it the DC or RC?

A. The DC awards VST prestige for everyone but themselves. The RC awards VST prestige for DC's and for VST's of Independent Chapters.

Q. Who awards prestige for a non-Camarilla domain website (yahoo groups site for example)

A. Provided the website is sanctioned (as per the sanctioning rules on a website that is currently offline, if you can't find it when the Camarilla websites come back online, let me know and I'll get it for you), the DC would award prestige for a Domain website.

Q. Where does Ordeal prestige go? Under Misc?

A. Prestige for Ordeals goes under "Ordeals". It is a separate category per the prestige template and should be listed as such in the next edition of the Handbook.
